FOOD VENDORS PLEASE NOTE — The City of Hampton Health Department always wants to make sure that all food safety rules are followed at all times to keep our patrons safe while they dine. Food vendors will need to have a state license or you will need to obtain a Temporary Food Application from the Health Department 15 days in advance of the event. You will NOT be allowed to obtain one on the day of the event. Representatives of the Health Department will be checking licenses, and any food vendor without a license will not be allowed to set up or sell at the Event.

Please do not plan your event participation until your submitted temporary food applications have been approved and you have received them in hand.
